



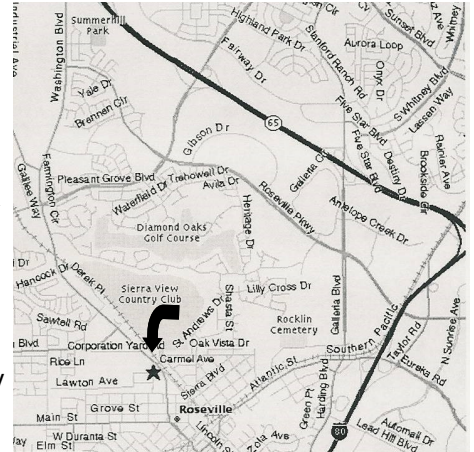
# Dolls & Teddy Bear Show & Sale
