

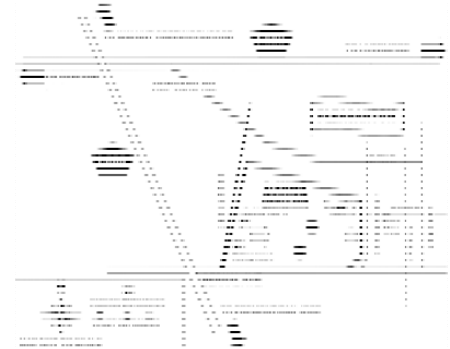


# Northern California Doll & Teddy Bear Show

- **The Alameda County Fairgrounds charges \$10.00 for parking** (eff. 1-1-15).
- Table covers are required, no general sale signs, all signs must be in good taste, all merchandise must be priced, and the exhibit must stay within the contracted space.
- Dealers will not start packing before 3:30PM Saturday.
- Smoking is not allowed in the exhibit hall. No pets allowed, except service animals.
- Cancellation Policy: Payments are not refundable. Cancellations are credited to a future show. No credit is given for cancellations within a week prior to the show set-up date.
