In addition to ribbon awards, many companies and individuals have donated prizes to show support and appreciation for creative work..

Entry Fee: \$7.50 per doll. There will be no limit to the number of entries per person. Make your check payable to Dolls4all. Dolls may be pre-registered by sending in the form below. Registration at the door will be \$15.00.

Challenge: SUMMER DREAMS

Judging: Danish judging method, awards will be presented at 2PM on June 29.

To Enter: You can register at any time and ship your doll at a later date. Fill out the attached form and send in with your fees, prior to June 18, 2003. You may bring your entry to the Fairgrounds on Friday, June 27 between 12 noon and 8PM. All dolls must be picked up by 4PM on Sunday, June 29, 2003. You must have your hang tag receipt to pick up the doll. You may mail your entry to: **Dolls4all 2630 Thomas Jefferson Dr. Reno, NV 89509.** Entries must be received no later than June 18 and must include your registration and return postage. Your entry will be returned the week of July 7, 2003. You will receive a confirmation and Hang Tag Receipt once the registration is received. Questions? The Rules

1. Contest entry dolls can be made from either an original or commercial pattern. If a commercial pattern is used, the creator of the pattern must be declared.
2. The Doll and costume must be made by the entrant and be entirely of cloth.
3. Dolls may have wire or other material used for armature
4. Props may be of any material, including purchased items. Stands and Props must be securely attached.
5. The contest is for single dolls (no Tableau's) between the size of 8" to 28", including props.
6. Dolls created in a face-to-face workshop or seminar are not eligible
7. Your name, address, phone/email needs to be on the doll, hidden from view
8. If you mail in your entry, include return shipping. Return shipping = the same amount that you paid to send to us. We will use the same box to return your entry. Be sure to package your item securely. Dolls4all and the Crossroads Doll & Teddy Bear show are not responsible for any damage that occurs in shipping. It would be a good idea to include a picture of how your entry should look, displayed.
9. Additional comments about your entry: Have you developed a new technique or have additional information about your entry? Let us know on the entry form.
